**A simple turnover of 200L Blue Plastic Drums was held on October 20, 2021 at the AWFPC Multipurpose Hall, Sitio Mahayahay, Barangay Anticala, Butuan City.**



The Butuan City Water District (BCWD) was represented by Mr. Ramil S. Barquin, OIC of the Management Services Department (MSD) and For. Ernie G. Ruiz, Environmental Specialist. They handed over the 200L Blue Plastic Drums to the partner beneficiaries to be utilized for the reforestation activities at the Taguibo River Watershed Forest Reserve (TRWFR).

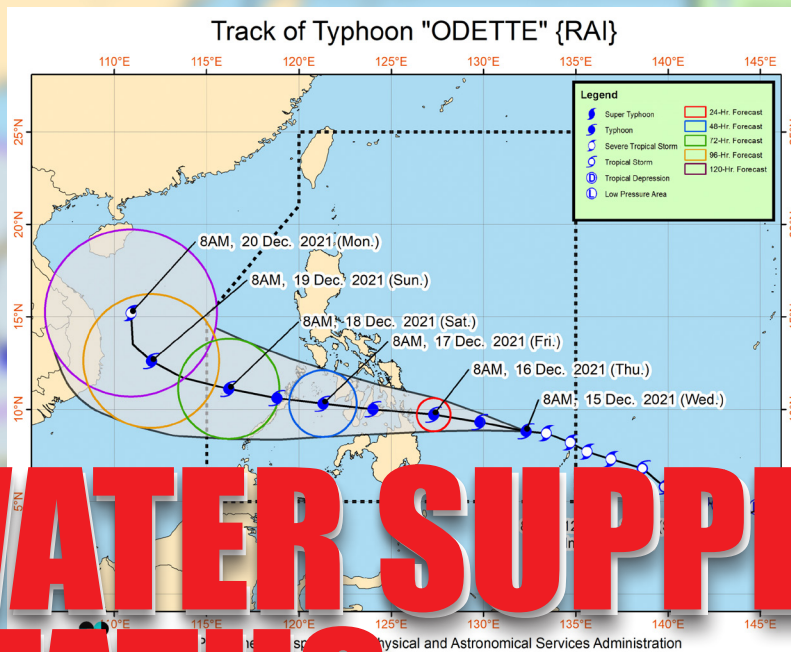
During his conversation with the partner beneficiary of the plastic drums, For. Ruiz emphasized the significance of preserving the Taguibo Watershed and how vital the role of the partner beneficiaries within the watershed for its protection and preservation. The participation of the inhabitants within the watershed will ensure the sustainability of all reforestation projects implemented within the TRWFR.

The BCWD Public Relations / Community Relations Programs implemented activities on Watershed Development for the Taguibo River Watershed Forest Reserve (TRWFR) which were divided into different categories. The categories include: **Information Drive, Community Support Program, Reforestation Projects, and Infrastructure Projects.**

BCWD's **Community Support Program** within the watershed provides the venue for creating rapport from the watershed settlers to be able to gather support during the implementation of several activities in the TRWFR.







# WATER SUPPLY STATUS

## after severe TROPICAL STORM ODETTE

The Butuan City Water District (BCWD) is currently operating under limited services due to the damaged water supply system of its bulk water supplier – the Taguibo Aquatech Solutions Corporation (TASC).



DEC 18

The Severe Tropical Storm Odette heavily damaged the facilities of TASC at Sitio Iyao, Barangay Anticala. As per TASC's update, part of the conveyance pipeline from the dam going to its Treatment Plant was disconnected and was carried away by the flashflood in the Taguibo River. The damaged pipe was a 1,100mm diameter Kurimoto pipe.



Based on TASC's update, the repair will take some time to commence as the Pianing Bridge in Barangay Pianing is not yet passable for any vehicle as the bridge was damaged at the height of Severe Tropical Storm Odette. As such, TASC cannot transport the materials and equipment needed for the repairs until such time that the Pianing Bridge will be rehabilitated. However, per TASC's commitment, the bulk water supplier will try to deliver water supply the earliest within seven (7) days from today. But TASC also committed to provide partial delivery of water supply up to 60% of the normal water supply by Wednesday, December 22, 2021.

The immediate action being taken by BCWD was to extract water supply from the four (4) pumping stations but the total production of the said pumping stations is only at 450 – 500 cubic meters per hour which is about 15% of the normal supply produced by BCWD for its concessionaires.

In order to bolster water supply up to the faucets of concessionaires, BCWD has done the following undertakings:

1. GM Anselmo Sang Tian already coordinated with the Local Water Utilities Administration (LWUA) to borrow the portable filter equipment which will supplement or augment the supply by having it available for concessionaires to obtain water, while TASC is working for the restoration of 100% of its water supply. Further announcement will be made when the equipment will arrive and as to where the equipment will be stationed



BCWD will continue with the water rationing through valving and by tanker until such time that the BCWD operations will return to normal.

The BCWD is asking everyone's cooperation by refraining from disconnecting service lines as it will reduce the pressure needed to serve concessionaires at farther distance from the source.



2. BCWD is also coordinating with Equiparco and Adfil to borrow water tankers so that BCWD can commence with water rationing to its concessionaires.

With these developments, BCWD is expecting to increase the current output of 15% of the four pumping stations to 75% by Wednesday thereby reaching numerous faucets of the concessionaires.





# DEC 19

As of December 19, 2021, the present water supply of the Butuan City Water District (BCWD) has been hampered due to the damages incurred to its bulk water supplier – the Taguibo Aquatech Solutions Corporation (TASC) at Sitio Iyao, Barangay Anticala brought about by Severe Tropical Storm Odette. Only four (4) pumping stations of BCWD are functioning to provide water to the city.



As an immediate solution to the problem, BCWD has been coordinating with the City Disaster Risk Reduction Management Office (CDRRMO) of Butuan City for the conduct of water rationing to provide water to all its concessionaires. As agreed upon during the coordination meeting at the Butuan City Hall, the CDRMO is responsible for dispatching the water tankers to the areas and for the conduct of rationing while BCWD is responsible for providing the water that the tankers use for the rationing. As such, BCWD ensures that its tapping point for the tankers is well maintained and does not have any leaks so that no water will be wasted during the loading of the water tankers. Personnel from BCWD are present to assist during the loading of the water tankers.

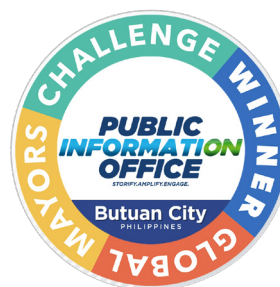

For the schedule of the water rationing, you may check the official Facebook page of the Butuan City PIO as they will be responsible for posting the schedule of water rationing for the day. The role of BCWD during the water rationing is to provide the water supply for the tankers.

Furthermore, BCWD is advising concessionaires that received rationed water from the tankers, not to drink the water directly as a safety precaution. Concessionaires need to boil the water before drinking or for cooking purposes. This boil advisory was issued as a health precaution to all concessionaires of BCWD.

# DEC 22



As of December 22, 2021, water pressure at Pump Station No. 1 of the Butuan City Water District (BCWD) is at 10psi (68.95 kPa). BCWD's bulk water supplier – the Taguibo Aquatech Solutions Corporation (TASC) has supplied water with an average flowrate of 16.525MLD (*million liters per day*) from 9:00AM of December 21, 2021 to 12:00 Midnight.



As such, the entire service area will still experience low water pressure to waterless situation. On the progress of TASC's rehabilitation of its facility at Sitio Iyao, Brgy. Anticala:

- The construction of the pedestal for the conveyance pipeline is already 100% completed and
- Repair of the access road for easy ingress and egress in the construction areas is ongoing.

# BCWD INSTALLS NEW LINES IN THREE AREAS FOR THE 4<sup>th</sup> QUARTER

The newly installed pipelines supply water with improved pressure as the previous lines serving the concessionaires in the said areas were previously installed temporarily. The expansion of these lines was requested by the concessionaires

located in Damayan, Barangay Libertad; Purok Gabi-C, Barangay Basag and Purok 3B, Barangay Ampayon, Butuan City. 

As part of the commitment of the Butuan City Water District (BCWD) in providing better service to its concessionaires, BCWD continues to conduct improvement and expansion projects.

For the 4th quarter of CY 2021, BCWD recently completed the installation of new pipelines in three (3) areas of Butuan City. The installation of new lines served as expansion to existing distribution lines. The pipes were buried at 0.50m deep. Materials used were mainly composed of Black High-Density Polyethylene (HDPE) Pipe.

**The installation of new lines was completed in Barangays Libertad, Basag and Ampayon, Butuan City with the following details:**

## BCWD PROVIDES TECHNICAL PERSONNEL

TO ASSIST TASC IN ITS REHABILITATION WORK

The main source of Butuan City Water District's (BCWD) water supply is through its bulk water supplier – the Taguibo Aquatech Solutions Corporation (TASC). Its water source is still the Taguibo River at Sitio Iyao, Barangay Anticala, part of the Taguibo River Watershed Forest Reserve.





During normal operation, TASC delivers a total volume of 50,000 cubic meters per day for the more than 54,000 service connections of BCWD.

This main water supply source of BCWD from TASC has been greatly damaged during the Severe Tropical Storm Odette with its conveyance pipeline from the dam going to its Treatment Plant was disconnected and was carried away by the flashflood in the Taguibo River.

TASC has already started with its mobilization and repairs of its

facilities at Sitio Iyao, Barangay Anticala, Butuan City on December 18, 2021.

On December 19, 2021, BCWD has sent technical personnel to assist TASC in the conduct of the rehabilitation of its conveyance pipeline going to TASC's Treatment Plant. Working together will enable to fast-track the rehabilitation works so that TASC can start delivering the required water supply volume needed for BCWD to have a normal water service to its concessionaires.

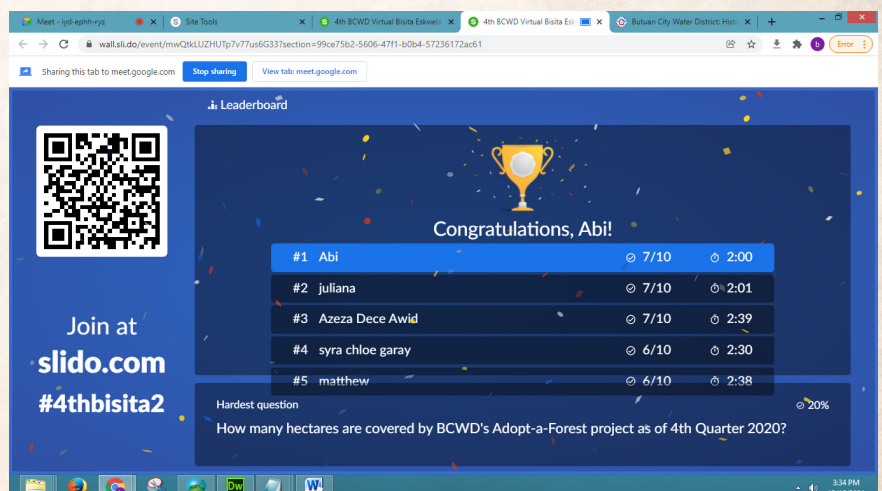
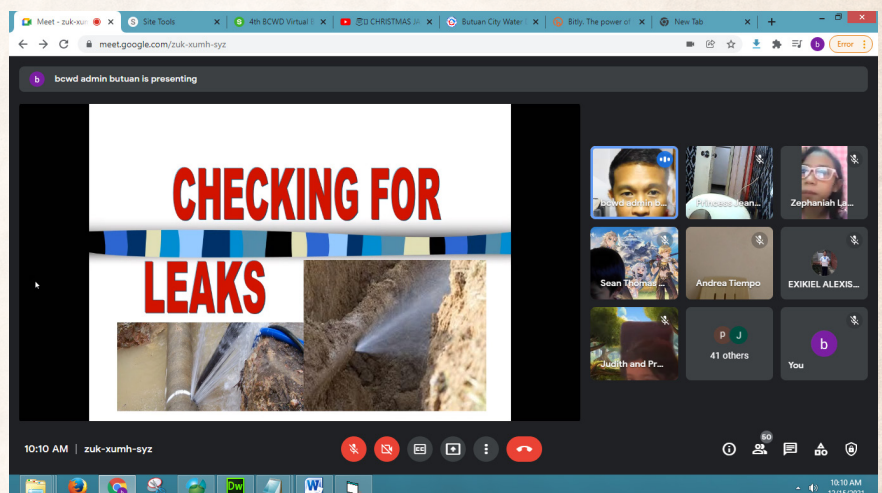
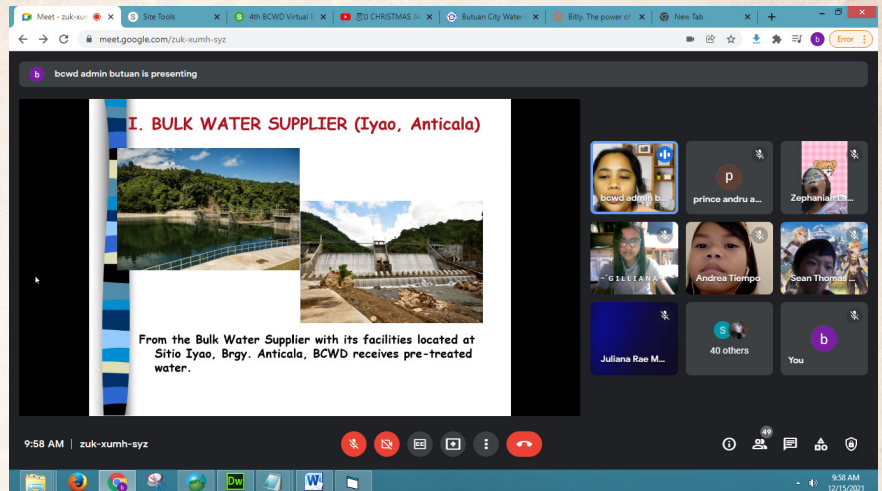


The Butuan City Water District (BCWD) also transforms the way it implements its water advocacy campaigns to adjust to the change in times, thus the conduct of its Virtual Bisita Eskwela, to be able to reach beyond the classroom.

BCWD conducted its 4<sup>th</sup> and final installment of the 2021 Quarterly Virtual Bisita Eskwela Program on December 15, 2021. A total of 46 elementary and jr high school students participated in the said activity coming from PECIT Elementary School and PECIT Junior High School.

# UNAUTHORIZED DISCONNECTION OF SERVICE LINES *to get water for domestic use* AFFECTS WATER SERVICE OF BCWD

The Butuan City Water District's (BCWD) operation has been greatly affected by Severe Tropical Storm Odette as the facilities of its bulk water supplier – the Taguibo Aquatech Solutions Corporation (TASC) at Sitio Iyao, Barangay Anticala has been severely damaged during the said typhoon.



Since December 17, 2021, BCWD has only been operating its four (4) pump stations to provide water supply to its entire service area. The four (4) pump stations are not enough to cater to the demand of its concessionaires as it can only provide at least 15% of the required water production. However, this 15% water production can already serve some barangays under its coverage area thereby minimizing the affected barangays without water.


By December 18, 2021, BCWD has observed that several concessionaires have started illegally disconnecting its water service lines from the water meter to

be able to store water for domestic use. This action has caused the water situation to worsen with the water pressure in BCWD's service lines lowering down thus depriving other concessionaires from having water supply in their faucets especially those near the water connection that was illegally disconnected.

Several BCWD personnel are already roving around the service area of BCWD to repair/rehabilitate the illegally disconnected service lines to be able to improve water pressure along the lines. However, there are some concessionaires who are reacting violently to the BCWD personnel conducting the

rehabilitation of the service lines that were illegally disconnected.

BCWD is asking everyone's cooperation by refraining from disconnecting service lines to improve water pressure so that other concessionaires will be able to have water in their faucets. BCWD has also been recording the service lines that were illegally disconnected so that legal actions can be taken.

Let us all work together so that we can overcome this crisis and normal water supply can be restored soon. 





# WHAT'S UP

*with BCWD's  
NRW Program*

**Non-Revenue Water (NRW) is a persistent problem of water districts. It is the difference between the volume of water being produced and the billed consumption of the consumers. These volumes of potable water are lost along the pipe network of a water utility before they reach to the meters of the consumers. NRW is a service indicator and an important aspect in prioritizing water system improvement.**

The Butuan City Water District (BCWD) adopted a long term solution in addressing arising issues on the NRW. One of which is the establishment of District Metered Areas (DMAs). DMAs are clusters of systems within the pipe network at large. The main function of the clusters is to narrow down or

prioritize the areas to be monitored by the maintenance of a water utility. BCWD started its DMAs in 2017.

Within the four (4) years since it started its DMAs, the NRW team of BCWD is currently managing and assessing four (4) operational DMAs namely: Banza + Maug,



Buhangin + Mahay, Mahogany and Tiniwisan + Cabcabon.

DMA's Banza + Maug and Buhangin + Mahay were established in 2017 and have an average NRW level of 14% or 1,782 cu.m and 20% or 4,036 cu.m. respectively, for year 2021. Additional operational DMA's: Mahogany and Tiniwisan + Cabcabon started in July 2021.

As part of the DMA management, the NRW team of BCWD is conducting data gathering such as tagging of service connections by the use of handheld GPS which include: tagging of existing and new service connections within the DMA, verifying water meter numbers, number of persons per household and analysis of consumption pattern (billed volume) for each concessionaire.

For the year 2021, the BCWD's NRW team tagged a total of 14,679 water meters in 15 barangays namely: Brgy. Baan Km. 3, Brgy. Ampayon, Brgy. Bonbon, Brgy. San Vicente, Brgy. Lemon + Pigdulan, Brgy. Pianing, Brgy. Antongalon, Brgy. Maon, Brgy. Pangabugan, Brgy. Villa Kananga, Brgy. Taguibo, Brgy. Baan Riverside, Brgy. Bading + Doongan, and Brgy. Villa Kananga. The team did not only focus on the four managed DMA's, but also included other barangays in the tagging of service connections.

In addition, BCWD's NRW team also performs active leak detection by walking through the line and detects leaks that are visible or with the use of a device to detect hidden

underground leaks. Detected small leaks were repaired on site immediately while major leaks were reported and repaired the following day.

For CY 2021, a total of 475 leaks were found, during the active leak detection activity.

Out of the 475 detected leaks, 429 or 90.32% of it were located at the Eastern Portion of the BCWD Service Area with Brgy. Ampayon as the area with the most leaks with a total number of 119 or 25.05% leaks, followed by Brgy. Antongalon with 100 or 21.05% leaks and Brgy. Taguibo with 66 or 13.89% leaks detected.

Furthermore, 46 or 9.68% were found on the Western Portion of the BCWD Service Area with Brgy. Doongan as the area with the most

leaks detected with a total of 12 or 2.53% leaks, followed by Brgy. Libertad with 10 or 2.11% leaks and Brgy. Bading with 9 or 1.89% leaks detected.

To date, BCWD continues to improve its NRW Program especially with its high NRW problem that requires its utmost attention to improve its services to its concessionaires.







# Access to safe water enhances people's quality of life:

the Construction of Water Supply System for Butuan City Rural Barangays Project of LGU Butuan and BCWD in a nutshell

**The Butuan City Water District (BCWD) and the City Government of Butuan entered into a Memorandum of Agreement (MOA) for the collaboration on the Detailed Engineering Design and implementation of the Project “Construction of Water Supply System for Butuan City Rural Barangays” on December 2, 2019. The said Project aims to provide access to safe water for its constituents especially those residing in far flung rural barangays where BCWD can no longer serve.**

Initially, there were 25 beneficiary barangays with a total of 26 water system projects proposed by the City Government of Butuan. The assigned Technical Staff from BCWD started with the preparation of the Detailed Engineering Design (DED) through the conduct of Preliminary Activities, Topographic Survey and Hydraulic Simulation/ Design of Pipelines. Estimate of Material Quantities, Construction Schedule and Final Design Report were also prepared for the approval of the City Mayor.

On June 1, 2021, out of the 26 water system projects, 12 DEDs were completed.

By December 6, 2021, one (1) barangay water system project was completely approved (Water Source Development Plan) since the DED of its distribution line was indorsed by the City on April 08, 2021.

On May 27, 2021, the City Engineer’s Office advised BCWD to prioritize implementation of eight (8) barangay water system projects, namely: (1) Barangay Pianing, (2) Barangay Anticala,


(3) Barangay Maibu, (4) Barangay Maguinda, (5) Barangay Don Francisco, (6) Barangay Manila de Bugabus, (7) Barangay Los Angeles, and (8) Barangay Aupagan.

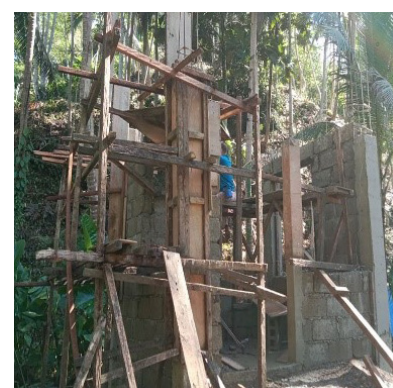
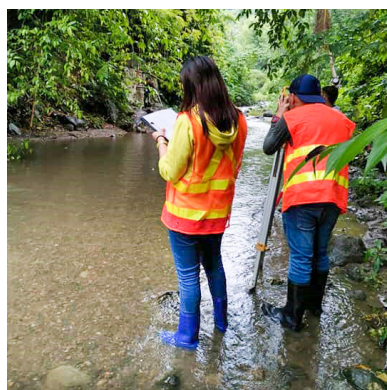
By July 15, 2021, the project assigned staff commenced with the mobilization of the project

through the conduct of the Pre-Construction Conference in each of the seven (7) beneficiary barangays, with the exception of Barangay Anticala, due to a water source ownership issue.

A total of 12,306 people will benefit from this project with a total of 2,156 service connections and 203 public faucets upon completion of this project.

Presently, the implementation of the project is at 34.79 percent.

BCWD having the absorptive capacity to construct a water supply distribution system because of the presence of the necessary tools and equipment needed was chosen by the City Government of Butuan to enter into a MOA for the implementation of the said project because it is more efficient and economical.
